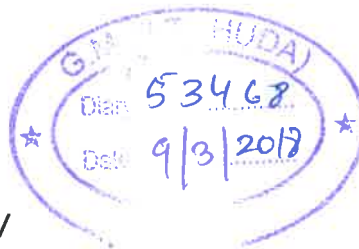

DATED:-****Subject:- Recovery of Additional Price (2nd EC) pertaining to the acquired land for the development of Sector-57, Gurugram.**

1. Please refer to subject cited above.
2. It is to inform you that on the basis of enhanced compensation awarded by the Hon'ble ADJ vide order no. 92/05 dt. 23.08.11, 427/04 dt. 23.02.10, dt. 15.12.11, 426/09 dt. 25.11.09, dt. 27.03.10, 57/05 dt. 26.02.10, 57/05 dt. 26.02.10, dt. 30.08.10 and Hon'ble High Court order no. RFA No. 2279/10 dt. 10.12.15, pertaining to the acquired land for the development of Sector-57, Gurugram, the recovery rate of additional price (**2nd EC**) has been worked out @ **Rs. 6784.47 Per Sq. Mtr. for General Category and @ Rs. 966.21 Per Sq. Mtr. for EWS Category**. The Additional price on account of this enhancement has been determined by the Chief Administrator, HSVP, Panchkula under Regulation 2(b) of Haryana Urban Development (Disposal of Land & Building) Regulation, 1978, which shall be payable by the transferees or lessee with respect to the land or building sold or leased to them in Sector-57, Gurugram. Detailed calculations are attached herewith at **Annexure "A"**.
3. You are requested to issue recovery notices immediately to the transferees or lessee with respect to the land or building sold or leased to them in Sector-57, Gurugram, under Regulations 10(2) of Haryana Urban Development (Disposal of Land and Building) Regulations, 1978 by intimating them the detailed calculations of additional price. The calculation in the notices generated may also be checked and confirmed before issue of notices to allottees.

Annexure-"A"

Calculation of additional price of Sector-57, Gurugram under Regulation 2(b) of The Haryana Urban Development (Disposal of land & Building) Regulation 1978.

1. As per policy approved by Authority vide Agenda Item No. 22 in its 111th meeting held on 27.07.2016, the calculations of the Additional Price under Regulation 2(b) of The Haryana Urban Development (Disposal of land & Building) Regulation 1978, are now being made in respect of Sector-57, Gurugram.

2. The first recovery notice dated 7.11.2012 of additional priced (CP/280) was issued based on payment basis of the amount disbursed in respect of enhancement awarded by ADJ for awards bearing Nos. from Sr. No. 9 to 16 .

While making the current calculation, it has been observed that Hon'ble High Court while disposing of RFA No. 2269 of 2010 vide order dated 10th Dec., 2015 has observed in para 10 of the order that enhanced compensation in respect of award No. 16 & 17 dated 20.12.2005 was increased to Rs. 1211/- & Rs. 2106/- per sq.yd. respectively by the Reference Court.

There appears to be no enhancement order passed by ADJ in respect of award No. 18,19,20 dated 20.12.2005. But while passing the order dated 10.12.2015 in RFA No. 2269 of 2010, the Hon'ble High Court vide para 26 of the order has observed that these are small pocket in between the area adjoining to the land acquired vide notification dated 24.8.2000 (Awards No. 9 to 15), and the compensation in respect of these awards has been enhanced @ 2403/- per sq.yd. (Village Waizrabad and Samuspur) and Rs. 1662/- per sq.yd.(Revenue Estates of Ghatta and Tigra).

Therefore, additional price calculation for award No. 18, 19, 20 dated 20.12.2005 have been made directly based on enhancement awarded by the Hon'ble High Court.

The net result is that for the current calculation, the orders of ADJ for Awards from 9 to 17 have been considered, where as enhancement awarded by Hon'ble High Court order in respect of Award No. 9 to 20 have been considered.

3. In view of the above calculations of additional price are prepared based on the information supplied by the Administrator, HUDA, Rohtak vide his Memo No. 214 dated 09.01.2018.
